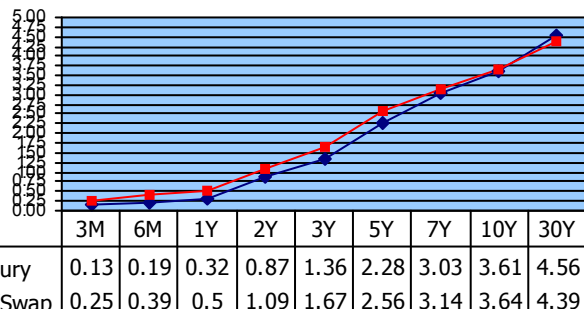




US Treasury Curve
